Linda Pigg Show Horses, Inc., Agent for Kids Gotta Secret, will herein be referred to as the Breeder. This service is subject to the following:

1. The following fees are applicable:
 - a. A nonrefundable booking fee of \$200.00 is due at the signing and acceptance of this contract.
 - b. The balance of \$550.00 is payable prior to any shipment of semen, plus all unpaid expenses will be payable upon receipt of an invoice or prior to the mare leaving the farm, whichever is first.
 - c. First collection is free. Any following collections are \$200/ea
 - d. Shipped semen fees are as follows:

i.	Bred at farm	\$150
ii.	Overnight Federal Express	\$275
iii.	Counter to Counter Air	\$375
iv.	Mare owner is responsible for returning the container to the breeder at Mare owner expense via Federal Express or USPS Priority Mail.	
 - e. Board at the farm is as follows:
 - i. Dry Mares \$15/day
 - ii. Wet Mares \$18/day
 - f. Board, veterinary, and other expenses are due each month. The account must be paid in full before the mare departs.
2. A photocopy of the registration papers (both sides) shall be sent to the Breeder with this contract. A current coggins and immunization records shall accompany the mare, otherwise the Breeder shall have the attending veterinarian perform all necessary examinations to insure breeding soundness at Mare owner's expense.
3. LIVE FOAL GUARANTEE: Live foal means the foal shall stand and nurse. Written certificate by a licensed veterinarian within seven days post foaling that above mare produced a nonviable foal will be proof of such. Mare owner verifies that such abortion or death did not result from any act or omission of care. Original mare owner will be entitled to a rebreed the following year. If open mare is sold with breeding, the new mare owner will be charged a \$250 administrative fee.
4. The breeding season is in force for this contract and shall begin February 1, 2016 and close June 30, 2016.

5. Breeders certificates will be issued to the Mare owner only after all expenses have been paid in full and upon notification of a live foal.
6. Should the above mare prove to be unsound for breeding or die, the mare owner shall be entitled to breed a substitute mare agreed upon by Stallion Management. If above mentioned stallion should die or be unfit to breed, breeding fees less the nonrefundable booking fee shall be refunded.
7. **Waiver of Liability:** It is understood that the breeding farm, its owners, Stallion owner, employees and guests shall not be liable for any injury, escape, disability or death of any horse on its premises. The above mentioned mare owner, whose horse is under the care of the Breeder, will not be liable or responsible for any damage, injury or death to the breeding stallion, employees, or other animals under the care of the Breeder.
8. This contract is not valid unless completed in full. The contract is non-transferable and non-assignable. When signed by both parties, the contract will be binding and subject to the above conditions.
9. Semen collections are performed on an every other day schedule. The Breeder must be notified no later than 7:00 PM CST on the day prior to semen collection to insure availability. Mares shipped to the Breeder will be given preference if availability is an issue.
10. Credit card payments will be charged a 3% service charge. Checks can be accepted online with no service charge. Notify Breeder to request online Credit Card or Check payments.
